**RESOLUTION
TO
ADOPT 2022 AD VALOREM TAX RATE**

A RESOLUTION LEVYING AN ANNUAL AD VALOREM TAX FOR THE YEAR 2022 SETTING SPECIFIC TAX RATES, APPLICABLE TO ALL REAL, PERSONAL AND MIXED PROPERTY SITUATED WITHIN THE ABBOTT INDEPENDENT SCHOOL DISTRICT.

BE IT ORDERED by the Board of Trustees of Abbott Independent School District of Hill County, Texas:

1. That an ad valorem tax rate for Maintenance and Operations for the general fund of \$.9050 per \$100.00 cash valuation be and the same is hereby levied for the year 2022 on all real, personal and mixed property located and situated within the boundaries of the Abbott Independent School District.
2. That an ad valorem tax rate for Interest and Sinking for the debt service fund of \$.41505 per \$100.00 cash valuation be and the same is hereby levied for the year 2022 on all real, personal and mixed property located and situated within the boundaries of the Abbott Independent School District.
3. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.
4. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 102.3499 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$252.64.
